

Instructions on the Revision of Prevention of Mother To Child Transmission Coordinating Committee

In reference to all National Guidelines on Prevention of Mother to Child Transmission (PMTCT), the National Center for HIV/AIDS, Dermatology and STD and the National Maternal and Child Health Center would like to present to all institutions and other related services its revision of the PMTCT Coordinating Committee as follows:

- 1. The PMTCT Coordinating Committee must be integrated into the Continuum of Care Coordinating Committee (CoCCC) at the Operational District Level.**
- 2. The Responsibilities of and Membership in the CoCCC must be revised as follows:**

2.1. Membership

13. OD HIV/AIDS Coordinator	<i>Secretary</i>
14. Chief of OD Maternal Child Health and PMTCT Coordinator	<i>Secretary</i>

2.2. Tasks of CoCCC

- Ensure collaboration of all relevant partners at Operational District Level and efficient use of existing resources.
- Determine the needs and gaps for cooperation and coordination between HIV/AIDS prevention and care and PMTCT at operational district level.
- Set mechanism for coordination between Referral Hospital, Home Based Care and Community Based Care for PLHA.
- Provide forum to express concern and discuss issues related to Continuum of Care and PMTCT activities.

3. For the province with more than two CoC sites, provincial CoC support group should be established:
