EXECUTIVE SUMMARY



For the Third quarter of the year 2006, \$1,437,267 was disbursed, representing 45% of the Annual Work Plan managed by NCHADS. This amounted to 78% of the Quarterly Work Plan, to support the implementation of the provincial and national activities.

I - ACTIVITIES AT THE PROVINCIAL LEVEL

85% of the third quarter-approved budgets were spent to support the implementation of activities in the Provinces funded by DFID, GFATM-R1, R2, EUROPAID and CDC. IEC, 100% CUP, Outreach, Continuum of Care and Management and coordination Activities were strengthened in the 24 provinces.

II - NATIONAL ACTIVITIES

To strengthen the implementation of programme at both levels, a set of national activities were implemented at NCHADS. These included the following:

IEC, BCC AND 100% CONDOM USE PROGRAMME

To support the HIV/AIDS campaign for the provincial level during Water Festival and WAD, BCC Unit developed, printed, and distributed the IEC material 6000 caps, and 6000 T-shirts.

To strengthen the capacity of the Provincial Support Team on Outreach, Peer Education and 100% CUP, National Technical Working Group conducted 2 sessions of the training course on OPC.

To monitor implementation of the programme, the supervision visits on IEC activities, Peer Education, outreach activities, and 100% CUP were carried out by BCC officers in Kampong Speu, Sihanouk Ville, Kampong Cham, and Kratie.

STI/RTI CASE MANAGEMENT

To ensure the good implementation of STD activities, STD officers conducted TWG meetings to finalize the Policy and Guidelines for STI management guideline for the general population, and developed appropriate curricular and training materials.

Staff of the STD Unit provided technical support and supervised in-service training on STD case management to SWs at STD Clinics in Kampong Speu, Sihanouk Ville, Kampong Cham, and Kratie.

In collaboration with BCC Unit, STD Unit organized one 2-day coordination meeting on STD and Outreach and 100% CUP with participation from PAO Managers, POT, and STD clinic officers from 24 provinces-cities.

CONTINUUM OF CARE FOR PLWHA

The 5th training course on Adult HIV/AIDS Care on OI and ARV for clinicians from Referral Hospitals of 17 provinces-cities, and the 4th course on OI/ARV counseling for nurses, were conducted.

Technical Assistance on implementation of CoC, IC, HBC was provided to Prey Veng, Takeo, Siem Reap, Phnom Penh, Pursat and SVR provinces through the workshop by the AIDS Care Unit staff. AIDS Care officers went to Koh Kong and Kampong Chhnaing to provide the TA on basic HIV/AIDS and UP workshop.

In collaboration with CENAT, NCHADS organized 2 sessions on Orientation Workshop on TB/HIV collaborative activities for Health Care Officers from RHs, HCs in Kampot and Sihanouk Ville.

The VCCT unit conducted training courses on counseling, Lab and testing for 45 VCCT staff from 17 provinces-cities.

6 supervision trips were made to provide technical support on Lab and Counsel in PVG, KRT, BTB, PST, KDL, and KPT.

SURVEILLANCE AND RESEARCH:

The Unit organized the meetings to discuss and develop the Protocol, standard form, Sampling and supply issues for HSS 2006 and the consensus meeting on dissemination of the result of STI Surveillance Survey 2005.

With collaboration with the National Center in HIV Epidemiology and Clinical Research, and University New South Wales, Australia, and sponsored by Roche Company, NCHADS organized the First Phnom Penh Symposium on HIV Medicine with 415 participants from RHs, NGOs and partners from 24 provinces. The objective of this Symposium was to share experience among people working in the field of care for PLHA, improve and increase the knowledge of health care providers, clinicians, counselors, lab technicians.

PROGRAMME PLANNING, MANAGEMENT AND COORDINATION

The Planning Monitoring and Reporting Unit organized 2 trainings on HIV/AIDS Management for OD Coordinators from 18 ODs.

The Unit organized the workshop on Review of PBSI Procedure for Provinces-cities with 52 participants from 20 provinces - cities and NCHADS. The objectives of this workshop were to introduce the PBSI Scheme for NCHADS Program and some new additional format and to re-orient the PBSI procedure for provinces-cities.

The Data Management Unit installed and conducted site- training the new database of VCCT and STD in Computers in KSP, KHK, TKV, KPT, SHV, BMC, BTB, PLN, KCM, SVR, PVG, KRT, SRP, and KTM.

The Logistic Management Unit organized 2 training courses on OI/ARV logistic Management for Pharmacy at OD level, and 2 sessions of Refresher training on Logistic Management for STD clinics.

The Planning Monitoring and Reporting Unit joint supervision trips with Logistic Management Unit and Finance Unit to monitor the HIV/AIDS Program Management in PNP, KDL, PLN, SRP, OMC

450 copies of the quarterly reports were produced and distributed to provinces and donors for their feedback of the implementation of the program.
